



WAIVER OF LIABILITY AND CLAIM RELEASE

I, _____, acting in my capacity as a representative of the team or club mentioned in this document (hereinafter referred to as "the Team"), declare my intent to participate and allow the members of my team to participate in the SPORTI 2026 PROGRAMS (the "Events"), which will be held at Sporti Soccer Complex (the "Facility"). These events will take place from January to December 2026 and include all activities related to training sessions, soccer matches, special events, and any related transportation to, from, and between event locations. In consideration of the privilege of participating in the Events, I hereby agree to and waive the following:

1. Release of Liability

In the event of any damage, injury, loss, or harm related to my participation or that of my team members in the Events—including but not limited to serious personal injury, paralysis, disability, or even death, as well as loss or damage to property—I irrevocably waive any right to file a claim or legal action against:

- The Event sponsor,
- The Facility manager,
- The Facility owner (Sporti USA, LLC),
- The City of San Antonio (COSA),
- The released parties mentioned above, and
- Any coaches, medical personnel, volunteers, staff, or agents of the aforementioned parties.

Furthermore, I hereby release, discharge, and agree to indemnify the above-mentioned parties from any liability, costs, expenses, or claims for damages, injuries, or losses arising from my participation or that of my team members in the Events.

2. Assumption of Risks

I acknowledge and fully assume the risks inherent in my team's participation in the Events, including but not limited to the risks of serious injury, paralysis, disability, or even death, as well as the loss or damage of personal property. I understand these risks and accept that Sporti USA and the Facility are not responsible for them.

3. Authorization for Medical Treatment

I authorize the coaches, medical personnel, or healthcare staff contracted by the Event sponsor or Facility manager to treat any injuries or medical conditions affecting my team members during the Event. Additionally, I authorize the transportation and admission of any player to a hospital or medical facility for diagnosis and treatment, if deemed necessary by the Event's medical staff.

4. Media Rights

I understand and agree that photographs, video recordings, and other media recordings of participants, including my team members, may be taken during the Events. I acknowledge that Sporti USA, LLC. and the Facility shall have exclusive ownership of these materials, including the rights to use, distribute, publish, and reproduce them in any medium, whether currently known or developed in the future, without any additional compensation to me or my team members.

5. Waiver and Release

I have signed this Waiver and Release on behalf of myself and my team members, as well as on behalf of our heirs, assigns, and legal representatives. I commit to ensuring that all team members understand and agree to the terms of this agreement.

6. Jurisdiction and Governing Law

This agreement shall be governed by and interpreted in accordance with the laws of the State of Texas. Any dispute arising from this agreement shall be resolved exclusively in the courts located in the State of Texas.
